ORDER

As per the Government order read as 1st paper above the Agricultural Insurance Company of India Ltd (AICIL) has been selected as the implementing agency of both Pradhan Mantri Fasal Bima Yojana (PMFBY) and Restructured Weather Based Crop Insurance Scheme (RWBCIS) in Kerala for Rabi 2021 season. As per Government Orders read as 2nd and 3rd papers above, sanction was accorded to release an amount of Rs. 7,08,30,913/- and Rs. 15,79,77,401/- as first and second installment respectively of state share of premium subsidy to Agricultural Insurance Company of India Ltd towards PMFBY& RWBCIS for Rabi 2021.

As per the letter read as 4th paper above, the Director of Agriculture Development and Farmers Welfare Department has requested for Administrative Sanction and release of an amount of Rs. 423.75626 lakh (Rupees Four Crores Twenty Three Lakhs Seventy Five Thousand Six Hundred and Twenty Six Only) being the third

installment of state share of premium subsidy to Rabi 2021 under PMFBY and RWBCIS under the H/A 2401-00-109-65-02 Plan.

Having examined the matter in detail, Government are pleased to accord sanction for the release and pay of Rs 423.75626 lakhs (Four crores twenty three lakhs seventy five thousand six hundred and twenty six only) for disbursing the amount to the Agriculture Insurance Company of India as 3rd installment under the scheme PMFBY and RWBCIS for the season Rabi 2021-22 from the current year's Budget provision available under the head of account 2401-00-109-65-02(PV).

4. The Director, Agriculture Development and Farmers Welfare Department is authorised to draw and disburse the amount to Agricultural Insurance Company of India Ltd (AICIL) during the current financial year.
