Sub: Agriculture Department –Establishment- Provisional Seniority List of L.D. Clerks for the period from 01. 01.1997 to 31.12.2006- published –reg.

As per this office order read as 1st paper above, the final seniority list of L.D. Clerks in Agriculture Department as on 01.01.1997 was published.

A provisional seniority list of L.D. Clerks for the period from 01.01.1997 to 31.12.2006 was published vide this office order read 2nd above, directing the controlling officers to circulate the list among all those concerned, including those on deputation/redeployment to Local Self Government department and inviting objections, or requests for addition/omission , if any, in the list.

Some of the incumbents have filed objection that seniority of L.D. Clerks appointed on Dying-in -Harness should be reckoned on the basis of the date of order of the appointing authority as per G.O.(P) No.19/91/P & ARD dt. 28.05.1991. The G.O. has been examined in detail and found that the claim/objection is genuine. Besides, it was found that a number of L.D. Clerks on redeployment to Local self Government Departments who were appointed between 01.01.1997 and 31.12.2006 have not been included in the list inadvertently. Therefore, the provisional seniority list of L.D. Clerks for the period from 01.01.1997 to 31.12.2006 published vide this office order read 2nd above is hereby cancelled and the provisional seniority list prepared afresh on the basis of the G.O. read 3rd paper above, which is appended to this circular and the same is hereby published.

The L.D. Clerks concerned shall file objections, if any concerning their seniority / other particulars in the list with documentary evidence duly authenticated by the controlling officers in support of their claims through proper channel so as to reach the same in this office on or before 31. 03. 2010. The controlling officers should verify the provisional seniority list appended in reference to the service books of the incumbents concerned, and discrepancies if any noticed, including the particulars of order of appointment, date of birth, present station where the incumbent is working, etc., furnish the same in no time and transmit it so as to reach the same in this office on or before 31. 03. 2010. Any laxity in this behalf will be viewed seriously and for non reporting of

errors, omissions and additions in respect of the L.D. Clerks under their control in time, the respective controlling officers will be held responsible.

Objections / recommendations for alterations of seniority received after 31. 03. 2010 will not be entertained under any circumstance.

All Principal Agricultural Officers / Controlling Officers shall furnish a certificate to the effect that this provisional seniority list has been circulated among all the concerned working under their control on proper acknowledgement in time.
