Government have approved the select list, as per the Government Order cited, consisting of the following 2 officers for the post of the Agricultural Officers to be appointed under by-transfer promotion method from the Agricultural Assistants under 13% quota.

As on now, only 2 vacancies of the Agricultural Officers under 13% quota are available.

In the circumstances stated above, the following Agricultural Assistants are hereby promoted under by-transfer promotion quota to the post of Agricultural Officers in the scale of pay Rs.55,200-1,15,300/- and posted in the Krishi Bhavans noted against their names :

The incumbents on by-transfer promotion are placed on probation for a period of 2 years of duty within a continuous period of 3 years from the date of officiation in the post of Agricultural Officer. They should also pass Account Test (Lower) within the period of probation.

The Principal Agricultural Officers should report the date of relief and joining of the incumbent along with the copy of the RTC to be reached to the

undersigned and the Accountant General (A&E), Thiruvananthapuram in due course.

The Service Book of the incumbents should be forwarded to the Directorate of Agriculture, after updating all the entries, by the Head of the office.

Since the sanctioned strength of Agricultural Officers under 13% quota is fixed as 143 and the posting of the junior-most Agricultural Officer will be liable to be reverted as and when the Agricultural Officer on deputation returns to the Department.
