4	Brief Description of Work	This work envisages protecting the sides of Ummini Paittankunnam canal which serves both irrigation and drainage canals during lean and rainy seasons respectively. Most of the sides of this canal are severely damaged leading to floods and loss of crop. Hence this work is taken up to protect the sides of the canal where the breach is more and the total length of side protection comes to 950m. Considering the field soil characteristics and taking account of the failure of existing masonry structures, nonavailability of good boulders, skilled labor and moreover considering the economic factor, it is proposed to construct a retaining wall for a length of 950 m and height 1.5 m, using C.C.1:4:8 for foundation, C.C 1:3:6 for footing and superstructure with skin reinforcement. Tractor crossing slabs and top slabs are proposed with RCC 1:11/2:3.
