<u>ORDER</u>

As per the Government Order read as 1st paper above the Agricultural Insurance Company of India Ltd. (AICIL) has been selected as the implementing agency of both Pradhan Mantri Fasal Bima Yojana(PMFBY) and Restructured Weather Based Crop Insurance Scheme (RWBCIS) in Kerala for Rabi 2022-23 season.

2. As per the Government Order read as 2nd above sanction was accorded to release an amount of Rs.10,83,85,257 lakhs (Rupees Ten Crore Eighty Three Lakh Eighty Five Thousand Two Hundred Fifty Seven Only) from the Head of Account 2401-00-109-65-02 (PV) for payment of the first installment under the scheme PMFBY-RWBCIS, Rabi 2022-23 to the Agriculture Insurance Company of India Ltd. (AICIL).

3. As per the letter read as 3rd paper above, Direcotr of Agriculture has requested to accord sanction to release Rs 23,18,86,991/- (Rupees Twenty Three Crore Eighteen Lakh Eighty Six Thousand Nine Hundred

Ninety One Only) by additionally authorizing the balance amount required for Rs.9,62,62,617/- (Rupees Nine Crore Sixty Two Lakh Sixty Two Thousand Six Hundred Seventeen Only) in the head of account 2401-00-109-65-02 (P), for payment of 2nd installment to the Agriculture Insurance Company of India Ltd. (AICIL) for Rabi 2022-2023 under the scheme PMFBY-RWBCIS.

As per the Government Order read 4th paper above authorisation has been given for additional expenditure to the tune of Rs.9,62,63,000/- (Rupees Nine Crore Sixty Two Lakh Sixty Three Thousand Only) under the Head of Account 2401-109-65-02 (P) for meeting the requirement of second installment of the state share of the premium subsidy for the RABI 2022–23 PMFBY scheme.

Having examined the matter in detail, Government are pleased to accord sanction to release an amount of Rs 23,18,86,991/- (Twenty three crores eighteen lakhs eighty six thousand nine hundred and ninety one only) from the Head of Account 2401-00-109-65-02 (P) for payment of the second installment under the scheme PMFBY-RWBCIS, Rabi 2022-23 to the Agriculture Insurance Company of India Ltd. (AICIL).

5. The Director, Agriculture Development and Farmers Welfare Department is authorised to draw and disburse the amount to Agriculture Insurance Company of India Ltd. (AICIL) during the current financial year.
