Agriculture Development & Farmers' Welfare Department, Government of Kerala invites online etender bids in two cover system from competent Firms (Disposal Facilities of Hazardous Waste) or their distributors/ dealers (herein referred to as "Bidder" till the award of Contract and therein on award of contract, referred to as "Vendor/ contractor/ Supplier / Successful Bidder") for the "**Disposal of Left-over Pesticides**". The successful bidder shall be finalized based on competitive bidding process. The bidders are advised to study the e-tender document carefully. Submission of bids shall be deemed to have been done after careful study and examination of the e-tender document with full understanding of its implications. **The bidder should be able to bid and comply the disposal within the stipulated time as per Hazardous and Other Wastes (Management, Handling and Trans Boundary Movement) Rules 2016 and Motor Vehicle (Amendment) Act, 1988.** The tender timeline is available in the critical date section of this tender published in www.etenders.kerala.gov.in.

Other Special Conditions

1. The Leftover pesticides should be collected from the store Room of State Pesticide Testing Laboratory, Parottukonam, Nalanchira PO, Thiruvananthapuram-695015, Kerala.
2. For disposal of materials coming under the categories of Hazardous Wastes, the bidders in order to be eligible to bid at the e-auctions must have the requisite valid permissions /approvals/clearances by way of registration, consent to operate and authorizations from the prescribed authorities including the Central Pollution Control Board and/or concerned State Pollution Control Board in terms of the Hazardous and Other Wastes (Management, Handling and Trans Boundary Movement) Rules 2016, or any other statutory modifications or enactment thereof. The bidder shall have authorised facility for secured land fill/ incinerator or other facilities for disposal of hazardous waste.
3. The Leftover Pesticides of both Solid and Liquid are separately stored in 50 Litres to 100 Litres of plastic containers.
4. The bidder who has the authorised facility for the disposal shall comply with Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016.
5. The transport of the hazardous waste should be in accordance with the provisions of the rules made by the Central Government under the Motor Vehicle Act, 1988 and the guidelines issued by the Central Pollution Control Board.
6. The bidder shall also obtain all statutory permissions as may be required.
7. The rate quoted (BOQ) should include all expenditure including all kind of taxes, collecting of pesticide from store room, Labourer, Loading, Transportation, Unloading and Disposing. Any other payments will not be accepted other than the amount quoted in BOQ.
8. The bidder who has the authorised facility for the disposal shall have registration in the CPCB's portal for 'National Hazardous Waste Tracking System'.
9. The Bidder should submit quote for disposal of both liquid and solid hazardous waste on per Kg/Litre rate (this should be inclusive of treatment charges and loading/unloading charges) plus transportation.
10. The lowest quoted bidder (Total Amount of both processing charges and transporting) will be approved subject to the sanction of the Director of Agriculture Development & Farmers Welfare Department, Thiruvananthapuram, Kerala
11. Manifest as per the Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016 shall be provided to the respective Pollution Control Boards by the bidder who has the authorised facility for the disposal.
