**ORDER**

As per Government Order read as 1st paper above Administrative Sanction was accorded for *Paramparagat Krishi Vikas Yojana 2017-18*. The first installment of 2017-18 amounting to 50% of the first year programme was released as per the Government Order read as 2nd paper above. As per Government Order read as 3rd paper above sanction was accorded to release an amount of **₹856.5688 lakhs** released by Govt. of India as the 80% of the second installment for the first year, for 500 clusters started in the year 2017-18 .

2. The Director of Agriculture as per the letter read as 4th paper above had informed that there was considerable delay in implementation of the scheme due to several contingencies. The Second Installment of the first year was released only during 2020-21 which has also caused a loss in continuity. Hence the Director of Agriculture has therefore requested to refund the Central share released in 2020-21 (₹856.57lakhs) to the Consolidated Fund of India and the corresponding State share (₹571.04 lakhs) to the

Consolidated Fund of the State.

3. Government have examined the matter in detail and are pleased *to accord Sanction for the refund of Central share already released and now remaining in the SNA account. The amount is to be credited to the RoP head* of the head of account from which the fund was earlier released to the SNA account.

4. Sanction is also accorded for refund of the Central share **₹856.57 lakhs** (Rupees Eight Crore Fifty Six Lakh Fifty Seven Thousand only) from the head of account '**1601- 00-900 Deduct Refund**' to the **heads of account under 3601** as follows:

**3601-06-101-43-06-31 : ₹ 770.91192 lakhs**

**3601-06-789-39-04-31 : ₹ 77.09119 lakhs**

**3601-06-796-43-04-31: ₹ 8.56569 lakhs**

5. Sanction is also accorded to refund the State share to the tune of **₹571.04 lakh** (Rupees Five Crore Seventy One lakh and Four thousand only) to the head of account '**2401-00-911-99 Recovery of Over Payments PV**'.

6. The Director of Agriculture shall take immediate necessary actions to carry out the refund process through *contra debit*.
