2	Location of Work	Alappuzha
3	Estimated Cost of Work	Rs.41295568/-

4	Brief Description of Work	<p>This estimate is prepared for 5 padasekharams at Pattanakkad block, Cherthala LAC, Alappuzha district as per the directions of higher authority. These infrastructural works are essential for increasing the crop production.</p> <p>Vettakkal A padam: New retaining wall is proposed from Udayan's plot towards north culvert end for 520m. The bund portion is filled with hard stiff clay for a length of 520m.</p> <p>Vettakkal B- 30cm of existing retaining wall is dismantled & raised by giving CC1:2:4 belt 10 cm thickness. A wearing coat of 7.5 cm is given on the top. Side of retaining wall is backfilled 950m for bund formation. 2 nos of pettychal base & sides is given RCC of 15 cm thickness. A farmroad of 175m of 2m height is given.</p> <p>Vettakkal C: 30 cm of the top portion of existing RW is dismantled for a distance of 1000m & repacked with dry rubble. A middle belt is provided with CC1:2:4 10 cm thickness. Back filling & bund formation is done with stiff clay. A culvert is constructed with 45cm DR masonry foundation of size 7.9x3.8. CC1:4:8 is provided with 20cm thickness & above that RCC1:2:4 is given for base & abutments. Top slab is given with RCC 30cm thickness.</p> <p>Vettakkal Kottalappadam: Retaining wall raising & bund formation is given for 550m length. vachal sidewall is given for 75m length.</p> <p>Pumphouse construction: A raft foundation with RCC 1:2:4 is constructed for 10cm thickness and plinth beam of size 30x20cm is given. 8 columns of size 25cm x25cm is given, solid block masonry & truss work with rafters & purlins is proposed.</p> <p>Chembakassery padam- construction of parakkuzhy & pettychal- construction of new parakkuzhy 5x4.5m size and pettychal 5x3.8m size and foundation strengthening with coconut pile driving and DR packing and CC1:4:8 retaining wall 10m length and 2m height, middle belt 1:2:4 & top wearing course 1:3:6. A motorshed is also constructed at Chembakassery padam by giving raft foundation & plinth beam.</p> <p>Formation of bund road west side proposed for 1000 m length & deepening of existing vachal is also given. Bund roads are formed using 50% of vachal deepening quantity and balance good earth is provided. 3 nos of sluice having 4.2x3m size with RCC 1:2:4 foundation strengthened with coconut piling, DR packing & CC1:4:8. 5 nos of culverts of size 7.2x3.6 foundation is given strengthened with coconut piling & DR packing.</p>

A bid submission fee shall be

remitted online during the time of bid submission.

Price Bid shall only be submitted through online. Details regarding remittance of Bid Submission Fee and Bid Security, Bid preparation and submission are mentioned in the bid document.

The bids shall be opened online on 12-02-2024 at 02:00 at the office of the O/o Office of the State Agricultural Engineer, Directorate of Agriculture in the presence of the Bidders /their authorized representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.

More details can be had from the Office of the State Agricultural Engineer, Agriculture Department (Agriculture Department) O/o Office of the State Agricultural Engineer, Directorate of Agriculture during working hours.

All other existing conditions related to bidding in force in the Kerala Public Works Department will be applicable in this tender also unless expressly defined in the bidding document. The Tender Inviting Authority/Employer shall not be responsible for any failure, malfunction or breakdown of the electronic system while downloading or uploading the documents by the Bidder during the e-procurement process. Details required for e-payment (Details of bank account having core banking facility and email address of the bidder) shall be furnished along with the tender. Tenders not accompanied by these details will be rejected. All subsequent Government orders connected to tenders and any revision in the rates of taxes would also be applicable to this tender.

Bonus will be paid to the bidder at the rate of 1% of the estimated PAC, subjected to a maximum of Rs.5 lakhs (Five lakhs) in case of works which exceed TS power of Superintending Engineer and also if and only if the work is completed within 85% of the original time of completion (TOC) specified in the TS estimate which is calculated as per the guidelines issued by the Chief Engineer of each wing.
