1. Introduction to KABCO and NAWO-DHAN

KABCO: KERALA AGRO BUSINESS COMPANY LIMITED (KABCO) is a Public Limited Company, incorporated under the Companies Act as a Company limited by Shares. It is classified as State Govt company and is registered at RoC-Ernakulam and vide GO(Ms) 74/2024/Agri dated 08.07.2024 KABCO has been nominated by the Government of Kerala as the Special Purpose Vehicle (SPV) to implement NAWO-DHAN.

NAWO-DHAN (New Agriculture Wealth Opportunities Driving Horticulture and Agribusiness Network Project): Fruits, Vegetables and Commercial crops farming has emerged as one of India's fastest growing and most profitable sectors, driven by rising demand for fresh and frozen produce both domestically and internationally. In Kerala, a unique initiative called "NAWO-DHAN," implemented by the Department of Agriculture (DoA) through the Special Purpose Vehicle (SPV) Kerala Agro Business Company "KABCO", aims to harness the potential of vacant, fallow, and underutilized land for hi-tech commercial farming. This program would promote advanced agricultural production practices including horticulture, protected cultivation, precision farming, hi-tech intercropping, hydroponics, apiculture, etc. By capitalizing on these unutilized land resources, NAWO-DHAN will aim to boost production levels, add value, generate employment, foster self-reliance, create valuable export opportunities and drive focused sector growth resulting in a major boost to the Kerala's economy. Primary objective of NAWO-DHAN project is to identify and cultivate high-value fruits, vegetables and commercial crops suitable for international markets; develop a sustainable and profitable farming model; enhance the income of farmers and Agripreneurs through export-oriented agriculture; promote modern and scientific farming techniques and to establish Kerala as a key exporter of high-value agricultural produce.

Role of KABCO in NAWO-DHAN

- KABCO will serve as the central coordinator for all parties involved under NAWO-DHAN, overseeing the planning and implementation of projects.
- KABCO, in collaboration with the Department of Agriculture, Government of Kerala, will facilitate the identification of vacant or underutilized land for commercial farming. This includes land available with PSUs, Government Departments/institutions, NGOs, trusts, and private lands in Kerala.
- Through Department of Agriculture, KABCO will also advise and provide guidance to the interested parties involved in NAWO-DHAN project in terms of providing information on project preparation, technical guidance on land and crop selection, costings, market related insights and other related information required for successful planning and implementation of the projects under NAWO-DHAN.
- KABCO will also organize matchmaking process and activities to connect interested parties with the
 projects, focusing on exports and international markets. This process will be governed by a service level
 agreement between the parties involved.
- KABCO will organize awareness programmes and publicity campaigns for NAWO-DHAN





2. Scope of Requirements

 A unique initiative called "NAWO-DHAN," implemented by the Department of Agriculture (DoA) through the Special Purpose Vehicle (SPV) Kerala Agro Business Company "KABCO", would like to explore the vacant lands, fallow lands, and underutilized land with PSUs, Government Departments/institutions, NGOs, trusts, and private lands, etc for hi-tech commercial farming in Kerala which are to be documented through various document tools

The selected agency will be responsible for:

- Documenting all activities including preliminary meetings, trainings, capacity building, B2B, B2C, reviews
 etc.
- Conducting field visits to various programme sites.
- Capturing high-quality video and photographic documentation.
- Producing a series of documentaries highlighting different aspects of programme.
- · Scripting, editing and post-production work to create engaging and informative content.
- Collaborating with the KABCO to ensure alignment with project goals.

A. Creating newspaper contents to report on the progress and success stories.

This involves producing written articles and reports that will be published in newspapers. The goal is to:

- **Highlight Key Milestones:** Regularly update the public on significant achievements and progress in the Commercial Farming initiative.
- **Feature Success Stories:** Share inspiring stories of cultivators who have benefited from the initiative, showcasing their journey and the impact on their livelihoods.
- **Provide Expert Insights:** Include interviews with agricultural experts and project leaders to offer deeper insights into the techniques and technologies being used.
- **Engage a Broader Audience:** Reach a wide audience, including policymakers, potential investors, and the general public, to raise awareness and support for the initiative.

B. Providing regular social media updates to engage the community and stakeholders.

This involves using social media platforms to keep the community and stakeholders informed and engaged. The strategy includes:

This involves organizing live broadcasts or recording sessions to provide an immersive experience of the farming activities. The approach includes:

- Live Demonstrations: Conduct live sessions through National TV Channels (Malayalam) where viewers
 can watch farming activities as they happen, such as planting, harvesting, and using advanced farming
 equipment.
- **Interviews with Farmers:** Record interviews with farmers to share their experiences, challenges, and successes, providing a personal touch to the documentation.
- **Educational Content:** Create informative sessions that explain the techniques and technologies being used, helping viewers understand the benefits and applications of Commercial Farming.
- **Audience Interaction:** Allow viewers to ask questions and interact with the farmers and experts during live sessions, making the experience more engaging and informative.
- **D. Producing a short film** (Reference: The elephant whisperers) summarizing the overall impact and achievements of the initiative





This involves creating a comprehensive short film that encapsulates the essence of the initiative. The film will:

- Narrate the Journey: Tell the story of the initiative from its inception to its current state, highlighting key moments and milestones.
- **Showcase Success Stories:** Feature in-depth profiles of farmers and communities that have benefited from the initiative, illustrating the positive impact on their lives.
- **Visual Appeal:** Use high-quality visuals, including drone footage, time-lapses, and close-up shots, to create an engaging and visually appealing narrative.
- **Convey the Message:** Clearly communicate the goals, achievements, and future aspirations of the initiative, inspiring viewers and potential stakeholders to support and participate in the project.

Eligibility Criteria:

- Availability of professional equipment and skilled personnel.
- Demonstrated ability to deliver high-quality content within stipulated timelines.

Submission Requirements:

Agencies are required to submit the following documents:

- Detailed proposal outlining the approach, methodology, and timeline.
- Financial proposal including cost estimates for the entire project for 1 year(one year).
