4	The under signed has the full authority to accept or reject any of the quotations without any reason thereof.				
5	All rules and regulation concerned to government quotation will be applicable here also.				
6	The rates quoted should be inclusive of GST, KFC, loading, unloading and transportations Charges.				
7	The delivery of refilled gas cylinders and collection of empty cylinders may be effected at laboratory site.				
8	Quotations will be accepted from the manufactures/authorized distributors only. Authorized distributor shall quote along with proof of authorization but the responsibility for supply and after supply services rests with authorized distributor.				
9	Only firms based at Thiruvananthapuram may quote and the items should be supplied within 24 hours of supply order.				
10	If the supply is not satisfactory or if there is any delay, the contract will be terminated forthwith without assigning any reason.				
11	The contract period will be for five months from the date of issue of work order. The contract may be extended for further period of one year based on the performance and mutual acceptance on the same rate, terms and conditions.				
12	The prices quoted are firm till the completion of the rate contract period. No price revision during the period of contract is allowed. However, if there is any reduction in the cost due to government policy etc, this reduction in cost must be passed on to this office.
