IT Cell was formed in Department of Agriculture Development and Farmers Welfare as per order referred 1st above and redeployed staff as per the revised staff pattern. As per the Order, 3 posts of Deputy Manager (IT) were created in the cadre of Agricultural Officer in IT Cell by shifting the posts from various offices. According to the order, applications were invited for various posts in the IT Cell vide reference cited 2nd above and prepared a panel of eligible candidates for appointment in IT Cell. Since the list of candidates has been exhausted and new vacancy arised in the IT Cell for the post of Deputy Manager (IT), notification has been issued vide reference cited 3rd above.

Since no eligible application as per notification has been received on or before the expiry of last date of receipt of application, the notification re notification is issued again for selection of suitable candidate for the post. Applications are invited for the post of Deputy Manger (IT) in the IT Cell of the Directorate , Department of Agriculture Development and Farmers Welfare, from Agricultural Officers having minimum 2 years service in field offices / PAO offices in the Department and having at least 4-5 years of remaining service.

Essential Qualifications as per GO referred 1st above:

PGDeG by Digital University of Kerala (IIITMK) / PGDCA or PG in any Computer Application / PG in Geo Informatics or Graduate / Post

Graduate degree in Computer Engineering / Computer Science / Computer Application / IT Networking and Cyber Security approved by Government of Kerala / Government of India.

Preference shall be given to members of Virtual IT Cadre / Post Graduate Diploma in e-Governance holders.

Applications should be in the prescribed format attached along with this circular. Copies of the claimed qualification / experience / certificates should be enclosed along with the application. Scanned copies of filled and signed application along with relevant copies of certificates should be recommended by the Controlling Officer / Head of Office and **should reach this office via email: krishidir.agri@kerala.gov.in on or before 5.00 PM of 21/10/2024.** Applicants should read the Government Order thoroughly before filling and submitting the application. If selected, the applicant should be ready to join the post at IT Cell , Directorate of Agriculture immediately.
